Terms and Conditions

1. Furry Friends Petsitting requires proof of vaccinations prior to accepting your pet(s). All dogs must have kennel cough vaccinations. These documents must remain with Furry Friends Petsitting whilst your pet(s) are on holiday with Furry Friends Petsitting.
2. The owner must confirm that they are the owner of the pet as outlined in the boarding contract and that the owner authorises Furry Friends Petsitting to act as guardian during the owner's absence and to take any action Furry Friends Petsitting considers it necessary to protect the health, safety and welfare of the pet (s). This includes euthanasia should the mentioned pet (s) suffer so severely that the vet and Furry Friends Petsitting agree euthanasia is the kindest solution.
3. The owner further confirms that the owner is responsible for all costs incurred either veterinary or other as a result of sickness. Accident or damage caused to or by the above mentioned pet(s).
4. The owner understands that no liability will be attached to Furry Friends Petsitting. Furry Friends Petsitting reserves the right to remove any pet in the event of destructive or disruptive behaviour and will endeavour to find alternative care should this happen. All dogs must be insured
5. Furry Friends Petsitting does not take bitches in season or coming into season, Furry Friends Petsitting are not liable for any pregnancies whilst in our care.

6. No dog (s) or dog hybrids registered under the Dangerous Dogs Act 1991 can be boarded with at Furry Friends Petsitting
7. All dogs must wear a correctly fitted collar and identity tag during their time in boarding. The tag must display the name, address and telephone number of the boarding premises.
8. All owners of dogs boarding at Furry Friends Petsitting agree and understand that their dogs will be boarding with other dogs.
9. The use of Furry Friends Petsitting will be deemed as acceptance of the terms and conditions.
